



STUDENT TECHNOLOGY AGREEMENT: GRADES 4-6

As a part of my schoolwork, my school gives me the use of Chromebooks/iPads and data storage space via Google. My behavior and language are to follow the same rules I follow in my class and in my school. To help myself, and others, I agree to the following promises:

1. I will use the Chromebooks/iPads *only* to do schoolwork, and not for *any other* reason. I will not store material on school-owned machines that is not related to my schoolwork.
2. I will use the Internet *only* with my teacher's permission and will *not* upload any software or apps without permission from my teacher.
3. If given a password, I will *not* give my password to anyone else, and I will *not* ask for or use anyone else's password. I will *not* add or change my password.
4. I will *not* put my address, telephone number or any other personal information about myself or anyone else on the Chromebooks/iPads. I will *not* plan to meet people contacted through the Internet.
5. I will use the Chromebooks/iPads for appropriate tasks and will *not* upload, link, or embed an image of others or myself without my teacher's permission.
6. I will play only teacher-approved games.
7. I will be polite and considerate when I use the Chromebooks/iPads; I will use grace, courtesy, and respect in all my interactions on the Chromebooks/iPads.
8. I will not try to see, send, or upload anything that says and/or shows bad or mean things about anyone's race, religion, or gender. If I see something bad or mean I will tell a teacher. If I use my Mill Falls email account, I will follow my teachers' instructions which will include direction about not opening suspicious attachments and only using appropriate language in my emails, among other instructions.
9. I will treat the Chromebooks/iPads with respect and not damage Chromebooks/iPads or anyone else's work. **I will not eat or drink near the Chromebook/iPad.**
10. If I have or see a problem with the Chromebooks/iPads, I will tell my teacher in person or by email.
11. I will not block or interfere with school's communications systems.
12. My teacher will look at my work and Chromebook/iPad (when in person) to be sure that I am following these rules, and if I am not, there will be consequences, which may include not being able to use the Chromebook/iPad.
13. If I damage a Chromebook/iPad on purpose, I will be responsible for reimbursing the school, and there will be additional consequences.
14. I will not purchase anything when using school Chromebooks/iPads. I will be responsible for reimbursing the school for purchases made.
15. When referencing articles or other items created by other people, I will be sure to state the author of the work I am using as a reference. If I do not do this, it is called Plagiarism. (Plagiarism is copying the work created by others and calling it your own and this is forbidden.)

16. I understand that the rules I must follow at school when using Chromebooks/iPads and all technology are also expected of me when I use them outside of school, and if my choices interfere with other students' education, and/or if I break the rules, there will be consequences in school.
17. I know that if I do not follow all the rules and expectations in this Agreement when I use a Chromebook/iPad there will be a consequence.

While Mill Falls employs filtering and other safety and security mechanisms and attempts to ensure their proper function, it makes no guarantees as to their effectiveness. Mill Falls will not be responsible financially or otherwise, for unauthorized transactions conducted over the school network or with school-loaned machines.*
